

**BOROUGH OF MILFORD**  
**ORDINANCE NO. 842-2015**

**AN ORDINANCE TO AMEND CHAPTER 42, SECTION 42-12,  
OF THE CODE OF THE BOROUGH OF MILFORD, TO REVISE  
THE WATER RATES OF THE MILFORD BOROUGH WATER DEPARTMENT.**

The purpose of this amendment is to increase water rates for all customers of the Milford Borough Water Department as is necessary to: Generate sufficient additional revenues necessary to both maintain the Water Department's operating surplus, and to maintain the Water Department's self-liquidating status.

**NOW, WHEREFORE, BE IT ORDAINED** by the Common Council of the Borough of Milford, in the County of Hunterdon, State of New Jersey that the following amendment(s) be and hereby is made to Section 42-12 of the Milford Borough Code, as follows:

**Section 42-12 Water Usage Rates.**

A. Where the Milford Borough Water Department has installed meters for determining the level of water usage by the customers of the Milford Borough Water Department the following water usage rates shall apply:

**For Calendar Year 2015 & Thereafter Until Revised by Ordinance.**

Each unit shall be charged a flat "Rental Fee" of \$42.00 per quarter. Additionally each unit shall be charged for actual water usage as follows:

- (1) First 3,000 gallons per quarter \$42.00 per quarter
- (2) 3,001 to 20,000 gallons per quarter \$3.75 per each 1,000 gallons per quarter
- (3) 20,001 to 30,000 gallons per quarter \$4.15 per each 1,000 gallons per quarter
- (4) 30,001 and over per quarter \$4.40 per each 1,000 gallons per quarter

All Ordinances or parts thereof which are inconsistent with the terms of this Ordinance are hereby repealed to the extent of such inconsistency.

This Ordinance shall take effect immediately upon its final passage and publication in accordance with State Law.
